

Geer, recorded in Plat Book H at page 177 and when described as a whole containing the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Ashley Avenue at the joint front corner of Lots 14 and 15 and running thence with the line of Lot No. 14, S. 24-30 W. 200 feet to a pin; thence N. 65-30 W. 110 feet to a pin at rear corner of Lot No. 17; thence with line of Lot No. 17, N. 24-30 E. 200 feet to a pin on Ashley Avenue; thence with the Southern side of Ashley Avenue, S. 65-30 E. 110 feet to the point of beginning.
