NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE

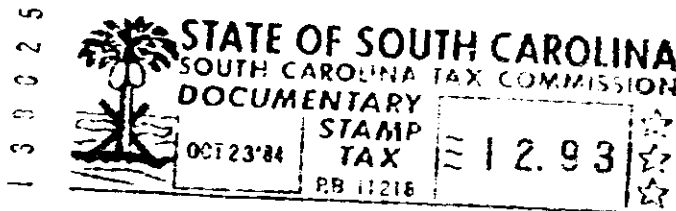
ALL that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, known as Lot 5 on a plat of the property of G. S. Garrett, recorded in the RMC Office for Greenville County in Plat Book Y, Page 92, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Pleasant Drive, at the corner of Lot 4, which iron pin is situate 283 feet west of the intersection of Hyde Circle, and running thence along said Circle, N. 76-45 E. 85 feet to an iron pin at the corner of Lot 6; thence S. 13-15 E. 173.8 feet to an iron pin; thence S. 84-13 W. 85.8 feet to an iron pin; thence N. 13-15 W. 162.7 feet to an iron pin at the point of beginning.

This conveyance is made subject to any restrictions, reservations, zoning ordinances, rights of way or easements that may appear of record, on the recorded plat or on the premises.

This being the same property conveyed to the Mortgagors herein by deed of Stella Mae T. Freeman recorded in the RMC Office for Greenville County in Deed Book 1224 at Page 706 of even date herewith.
