The Mortgagor shall not do or suffer anything which will materially increase the risk of fire or other hazard to the Mortgaged Property or any part thereof or which would or could result in the cancellation of any insurance policy maintained by the Mortgagor with respect to the Mortgaged shall not remove, demolish or The Mortgagor Property. materially alter all or any part of the Improvements without the prior written consent of the Mortgagee.
