TO ALL WHOM THESE PRESENTS MAY CONCERN: James R. Mills

Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto Bankers Mortgage Corporation

a corporation organized and existing under the laws of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Eighteen Thousand Five Hundred Forty and No/100ths----- Dollars (\$ 18,540.00).

with interest from date at the rate of thirteen and one-half per centum (13.50 %) per annum until paid, said principal and interest being payable at the office of Bankers Mortgage Corporation in Florence, South Carolina or at such other place as the holder of the note may designate in writing, in monthly installments of Two Hundred Twenty-Three and 96/100ths----- Dollars (\$ 223.96), commencing on the first day of January, 19 85, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of December, 2004.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville State of South Carolina:

All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina located on the western side of Hall Road being known as Lot 7 on a plat of John R. and Ollie L. Childress, prepared by Campbell & Clarkson, RLS, on September 11, 1970 and also being shown on a plat of survey made by Freeland & Associates, dated November 8, 1984 and having according to said plat of survey the following metes and bounds, to-wit:

Beginning at an iron pin on the western edge of Hall Road at the joint front corner of Lots 6 and 7 which iron pin is located approximately 273 feet south of the intersection of Hall Road with Tryon Avenue, and running thence S. 16-52 W. 70.01 feet along the western edge of Hall Road to an iron pin at the joint front corner of Lots 7 and 8; thence with the common line of said lots, N. 74-09 W. 124.92 feet to an iron pin; thence N. 16-52 E. 72.21 feet to an iron pin at the joint rear corner of Lots 6 and 7; thence with the common line of said lots, S. 73-08 E. 124.88 feet to an iron pin on the western edge of Hall Road, the point of beginning.

This is the same property conveyed to James R. Mills by deed of Stephen E. Beasley and Janice K. Beasley dated November 9, 1984 and recorded herewith in the RMC Office for Greenville County, South Carolina.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner herein provided. Privilege is reserved to pay the debt in whole, or in an amount equal to one or more monthly payments on the principal that are next due on the note, on the first day of any month prior to maturity; provided, however, that written notice of an intention to exercise such privilege is given at least thirty (30) days prior to prepayment.
