"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Notchwood Drive, being known and designated as Lot No. 7 as shown on a Plat of Parkdale, Section 2, made by C. O. Riddle, May, 1965, and recorded in the R. M. C. Office for Greenville County, in Plat Book "888" at Page 12, and having according to said Plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the eastern side of Notchwood Drive, at the joint front corner of Lots 6 and 7; thence with the common line of said Lots N. 63-47 E. 190 feet to an iron pin; thence running S. 26-13 E. 100 feet to an iron pin at the rear of Lot No. 7; thence with the line of Lot No. 7 and the line of Property owned by J. A. McJunkin, S. 63-47 W. 190 feet to an iron pin on the eastern side of Notchwood Drive; thence following the curve of the cul de sac, the chord of which is N. 3-47 E. 50 feet, to a point, and N. 56-13 W. 50 feet, to a point; thence running N. 26-13 W. 13.4 feet to the point of beginning.
