(hereinafter referred to as Mortgagee) its successors and assigns forever (hereinafter referred to as Mortgagor) as evidenced by the
Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of SEVEN THOUSAND
THREE HUNDRED EIGHTEEN DOLLARS AND 92/100----- Dollars (\$ 7318.92) due and payable

granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

Carolina, County of GREENVILLE , town: All that lot of land with the buildings and improvements
