MORTGAGE OF REAL ESTATE

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as Lot No. 8 of a Subdivision of Perry Property as shown on plat recorded in the R.M.C. Office for Greenville County in Plat Book "K", page 144, said lot being situate at the corner of the intersection of Duke and Drive and New Buncombe Road (now known as Poinsett Highway), reference to said plat being hereby made for a more particular description thereof.

The above-described property is identified on the Greenville County Tax Map as Sheet 167, Block 1, Lot 1N, and is the same conveyed to the Mortgagor by Elmer McCall, et al, by deed dated January 21, 1953, and recorded in the R.M.C. Office for Greenville County in Deed Book 470 at page 480.
