To All Whom These Presents May Concern:

I, Jimmy Taleff

hereinafter called

the Mortgagor(s), SEND GREETING:

WHEREAS, the said Mortgagor(s) in and by my certain promissory note in writing, of even date with these Presents, am well and truly indebted to BANK OF GREER, GREER, S. C., hereinafter called Mortgagor, in the full and just sum of **Fifty two hundred** - - - - - DOLLARS,

All that certain parcel or lot of land situated on the West side of School Street and the North side of Westfield Avenue in the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, and having the following courses and distances, to wit:

BEGINNING at the intersection of Westfield Avenue and School Street, and running thence in a northealy direction along School Street 156 feet to an iron pin; thence in a westerly direction 76 feet to an iron pin; thence in a southerly direction 156 feet to the north side of Westfield Avenue; thence along said Avenue 76 feet to the beginning corner.
