"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate, lying and being in the City of Greenville, being known and designated as lot no. 165 of Isaqueena Park on Plat recorded in Plat Book P, at page 130, R.M.C. Office for Greenville County, and being more particularly described according to survey and plat by J. Mac Richardson, dated September 21, 1960, as follows:

BEGINNING at an iron pin on the north side of Kirkwood Lane, corner of Lot No. 164; thence with the line of said lot, N. 9-31 E. 175 feet to an iron pin; thence S. 83-24 E. 106 feet to an iron pin in line of Lot No. 166; thence with the line of said lot, S. 23-42 W. 175 feet to an iron pin on said Lane; thence with said Lane, N. 48-51 W. 10 feet to a stake; thence S. 84-24 W. 57 feet to the beginning.
