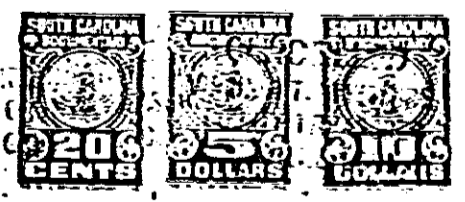

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and farther sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot #16 on plat of Gray Fox Run made by C. O. Riddle, Surveyor, November 6, 1975 and being recorded in the RMC Office for Greenville county in Plat Book 5P at Page 9. According to said plat, the property is more fully described as follows:

BEGINNING at an iron pin on Cavendish Close at the joint front corner of Lots 16 and 17 and running thence along the joint line of said lots N. 87-24 W. 140 feet to an iron pin in the line of Lot 15; thence with line of Lot 15 N. 2-36 E. 110 feet to an iron pin on Gray Fox Square; thence with said Square S. 87-24 E. 115 feet to an iron pin near the intersection of Cavendish Close; thence with the curve of said intersection S. 42-24 E. 35.4 feet to an iron pin on Cavendish Close; thence with said Close S. 2-36 W. 80 feet to an iron pin, the point of beginning.
