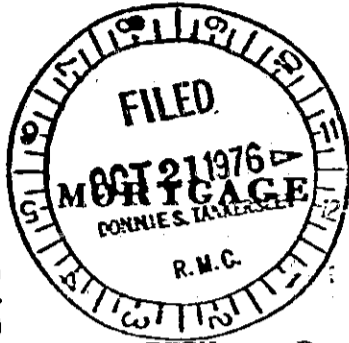

TO ALL WHOM THESE PRESENTS MAY CONCERN:

Roger K. Kercher and Janis F. Kercher

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-one thousand four hundred and no/100ths----- DOLLARS

(\$ 21,400.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 20 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, about one mile west of Gowansville on the northeastern side of S. C. Highway 11 containing 12.4 acres, more or less, being designated as Tract 1 on a survey for Harold Smith by W. N. Willis, Engineers, dated March 2, 1973 and being described, according to said plat, more particularly, to-wit:

BEGINNING at an iron pin on the northeastern side of S. C. Highway 11 and running thence N 24-00 E 1,050.00 feet to an iron pin in the right of way of a Duke Power transmission line; thence S 73-00 E 683 feet to an old stone; thence S 42-00 W 1,331.00 feet to an iron pin on the northeastern side of S. C. Highway 11; thence along and with the northeastern side of said Highway, N 39-00 W 300 feet to an iron pin, the point of beginning.

The above-described property was conveyed to the Mortgagors by deed recorded in the RMC Office of the Greenville County Courthouse in Deed Book 974 at Page 573.
