All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, on the northern side of Ivanhoe Circle, shown as Lot 56 on plat of Rosedale, recorded in Plat Book YY at page 35 in the RMC office for Greenville County and being further described according to said plat as follows:

BEGINNING at an iron pin on the northern side of Ivanhoe Circle at the joint front corner of Lot Nos. 55 and 56 and running thence along the joint line of said lots, N 16-08 E 150 feet to an iron pin; thence N 73-52 W 110 feet to an iron pin at the corner of Lot No. 57; thence along the line of Lot No. 57, S 16-08 W 150 feet to an iron pin on the northern side of Ivanhoe Circle; thence along Ivanhoe Circle, S 73-52 E 110 feet to the point of beginning.
