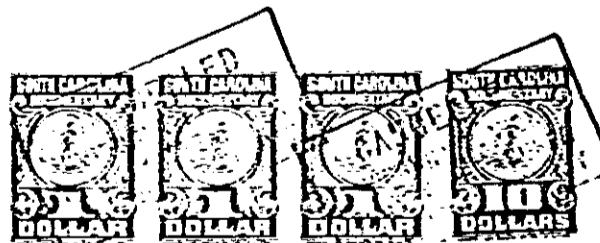

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in the Town of Mauldin, being shown and designated as Lot No. 166 on a plat of Forrester Woods, Section 4, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book 4R at page 68, and said lot having the following metes and bounds according to said plat:

BEGINNING at an iron pin on Royal Oak Road at the joint front corner of Lots Nos. 166 and 167, and running thence with the joint line of said lots, N. 22-05 W. 152.6 feet to iron pin; thence with the line of Lot No. 175, N. 66-55 E. 100 feet to iron pin; thence with the line of Lot No. 165, S. 22-05 E. 150.5 feet to iron pin on Royal Oak Road; thence with Royal Oak Road, S. 67-43 W. 100 feet to the beginning corner.
