WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Section I of Oak Crest Subdivision, known and designated as Lot No. Twenty-two (22) as shown by plat of Oak Crest Subdivision made by C. C. Jones & Associates, Engineers, and recorded in the R.M.C. Office for Greenville County in Plat Book GG, Pages 130 and 131, and according to said plat, having the following metes and bounds:

Beginning at an iron pin on the northwestern side of Templewood Drive at the joint front corner of Lots 21 and 22, thence along Templewood Drive S. 60-02 W., 55 feet to an iron pin; thence N. 74-58 W., 35 feet to an iron pin; thence along Brownwood Drive N. 29-58 W., 125 feet to an iron pin; thence N. 60-02 E., 80 feet to an iron pin; thence along the line of Lot 21 S. 29-58 E., 150 feet to an iron pin, the point of beginning.
