WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 147, Section III, Westcliffe Subdivision, as shown on plat thereof by Piedmont Engineers & Architects, December 11, 1963, revised September 24, 1965, recorded in the RMC Office for Greenville County in Plat Book JJJ at pages 72, 73, 74 and 75, and according to said plat having the following metes and bounds:

Beginning at an iron pin on the eastern side of Saluda Circle at the joint front corner of Lots 140 and 147, and running thence S 85-28 E 174.4 feet to an iron pin; thence running S 39-15 W 167.9 feet to an iron pin; thence running S 83-27 W 125.1 feet to an iron pin on the eastern side of Saluda Circle; thence with Saluda Circle, N 27-03 E 100 feet to an iron pin; thence continuing with Saluda Circle, N 09-02 E 70 feet to the point of beginning.

Being the same property conveyed to the mortgagors by deed of Hawkins-McCollum Builders, Inc., to be recorded herewith.

In addition to and together with the monthly payments of principle and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee the sum of 1/48th% of the original amount of this loan in payment of the mortgage guaranty insurance.
