"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northeastern side of Brook Glenn Road, near the City of Greenville, S. C., being known and designated as Lot No. 102 as shown on Plat entitled "BROOK GLENN GARDENS", dated October 28, 1965 and recorded in the RMC Office for Greenville County, S. C., in Plat Book JJJ, Pages 84 and 85, and having according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northeastern side of Brook Glenn Road at the joint front corner of Lots Nos. 101 and 102, and running thence with the line of Lot No. 101, N. 60-17 E. 150.0 feet to an iron pin in the line of Lot No. 118 at the joint rear corner of Lots Nos. 101 and 102; thence with the line of Lot No. 118 and 117, S. 29-43 E. 110.0 feet to an iron pin at the joint rear corner of Lots Nos. 102 and 103; thence with the line of Lot No. 103, S. 60-17 W. 150.0 feet to an iron pin on the Northeastern side of Brook Glenn Road at the joint front corner of Lots Nos. 102 and 103; thence with the Northeastern side of Brook Glenn Road, N. 29-43 W. 110.0 feet to the point of beginning.
