WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C. (hereinafter referred to as Mortgagee) in the sum of Seventeen Thousand Five Hundred and No/100-----DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Douglas Drive, being known and designated as Lot No. 35 as shown on a plat of Country Club Estates, prepared by Dalton & Neves, dated October, 1926, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book G at Pages 190 and 191, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the southern side of Douglas Drive at the joint front corner of Lots Nos. 34 and 35, and running thence with the line of Lot No. 34, S. 23-22 E. 150 feet to an iron pin; thence with the rear line of Lot No. 56, S. 66-38 W. 50 feet to an iron pin at the joint rear corner of Lots Nos. 35 and 36; thence with the line of Lot No. 36, N. 23-22 W. 150 feet to an iron pin on the southern side of Douglas Drive; thence with the southern side of Douglas Drive, N. 66-38 E. 50 feet to the point of beginning.
