M. C. Office for Greenville County in Plat Book M at Page 47 and being described, according to said plat, more particularly, to-wit:

BEGINNING at an iron pin on the northern side of DeOyley Avenue at the joint front corner of Lots 215 and 216 and running thence N. 0-13 W. 140 feet to an iron pin; thence S. 89-47 W. 90 feet to an iron pin in the line of Lot 217; thence S. 0-13 E. 140 feet to an iron pin on DeOyley Avenue; thence along the northern side of DeOyley Avenue, N. 89-47 E. 90 feet to an iron pin, the point of beginning.
