(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-six Thousand and No/00----- DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 295 on plat of Del Norte Estates II, made by Piedmont Engineers and Architects May 22, 1971 and recorded in the R.M.C. Office for Greenville County in Plat Book 4N, Pages 12 and 13. According to said plat the property is more fully described as follows:

Beginning at an Iron pin on Del Norte Lane at the joint front corner of Lots 294 and 295, and running thence with Del Norte Lane N 48-59 W 25.6 feet to an iron pin; thence continuing with said lane N 57-47 W 64.4 feet to an iron pin at the joint front corner of lots 295 and 296; thence with the joint line of said lots N 32-12 E 145.2 feet to a point in the center of Brushy Creek; thence with said creek as line S 54-55 E 105.0 feet to a point at the joint rear corners of Lots 294 and 295; thence with the joint line of said lots S 38-13 W 144.6 feet to an iron pin, the point of beginning.
