(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of FOUR thousand and no/100ths-----DOLLARS

(\$4,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is eight (8) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, on the southern side of Mountain Creek Road and according to plat by J. C. Hill dated June 22, 1950 described as follows:

BEGINNING at a stake on the southern side of Mountain Creek Road 277.1 feet east from Old Rutherford Road at corner of property of Lina M. Dillard and running thence S 78-30 E 169.1 feet to a stake; thence S 3-30 W 255 feet to a stake; thence N 46-20 W 243.1 feet to a stake at corner of property of Lina M. Dillard; thence with line of said property N 6-15 W 53.5 feet to a stake; thence N 26-00 E 75.1 feet to the beginning point.

The above-described property is the same conveyed to the Mortgagor by deed of Paul C. Dillard recorded in the RMC Office of Greenville County in Deed Book 506 at Page 231.
