(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that certain lot of land lying in the State of South Carolina, County of Greenville, on the western side of Hermitage Road shown as Lot 134 on a Plat of LAKE FOREST, SECTION III, recorded in the R.M.C. Office for Greenville County in Plat Book GG at page 77, and being further described according to the said plat as follows:
