TO ALL WHOM THESE PRESENTS MAY CONCERN: Robert K. Harding

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty Three Thousand Five Hundred and No/100-----DOLLARS (\$ 23,500.00--- ), with interest thereon at the rate of ---7½----- per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is ---25----- years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the east side of Balmoral Court being shown as Lot No. 199 on Section 3 B of a subdivision known as Westcliffe Subdivision recorded in the R.M.C. Office of Greenville County, S. C. in Plat Book JJJ, Pages 72 through 75 inclusive and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Balmoral Court at the joint front corner of Lots 198 and 199 and runs thence along the line of Lot 198 S. 65-29 E. 233.3 feet to an iron pin; thence N. 0-31 W. 290.3 feet to an iron pin; thence S. 57-02 W. 254.8 feet to an iron pin on the east side of Balmoral Court; thence with the curve of Balmoral Court (the chord being S. 21-53 E. 27.2 feet) to an iron pin; thence still with the curve of Balmoral Court (the chord being S. 11-29 W. 30.2 feet) to the beginning corner.
