TO ALL WHOM THESE PRESENTS MAY CONCERN: Glenn F. Haller and Mary H. Haller  
 (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty Thousand and No/100 ----- DOLLARS

(\$ 20,000.00-----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot No. 12 on plat of Valleybrook Subdivision as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4N, at Page 60, and having, according to said plat, the following courses and distances, to-wit: BEGINNING at an iron pin on the cul-de-sac of Deer Creek Drive at the joint front corner of Lots Nos. 12 and 13, and running thence with the line of Lot No. 13, N. 84-37 W. 110.6 feet to an iron pin; thence, S. 24-11 W. 197.2 feet to an iron pin; thence, S. 82-39 E. 104.4 feet to an iron pin at the joint rear corner of Lot No. 11; thence with Lot No. 11, N. 40-10 E. 166.2 feet to an iron pin on the cul-de-sac of Deer Creek Drive; thence with the curve of said cul-de-sac, the chord of which is N. 18-18 W. 60 feet to the beginning corner.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagors promise to pay to the mortgagee for the term of the guaranty policy the sum of 1/48th of one per cent of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on their failure to pay it, the mortgagee may advance it for the mortgagors' amount and collect it as part of the debt secured by the mortgage.
