THIS MORTGAGE is made this 2nd day of August 1976, between the Mortgagor, Gerald M. Padgett (herein "Borrower"), and the Mortgagee, South Carolina Federal Savings & Loan Association, a corporation organized and existing under the laws of United States of America, whose address is 1500 Hampton Street Columbia, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Fifty Thousand and No/100 (\$50,000.00) Dollars, which indebtedness is evidenced by Borrower's note dated August 2, 1976 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on April 1, 2002.

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, in the City of Mauldin, being known and designated as Lot No. 39 on plat of Forrester Woods, Section 7, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 5-P, at pages 21 and 22, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on Piney Grove Road, joint front corner of Lots 39 and 40, and running thence along the common line of said Lots S. 78-38 E. 174.9 feet to a point; thence turning and running with the rear line of Lot 39, S. 78-45 E. 100 feet to a point, joint rear corner of Lots 38 and 39; thence turning and running with the common line of said lots, N. 77-54 W. 195 feet to a point, joint front corner of Lots 38 and 39; thence turning and running with Pine Grove Road, N. 12-06 W. 100 feet to the point of beginning.
