All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the County of Greenville, State of South Carolina, and being known and designated as Lot No. 230, Sunny Slopes Subdivision, Section IV, according to a plat prepared of said Subdivision by C.
