WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty-Three Thousand Eight Hundred and no/100 DOLLARS (\$43,800.00---), with interest thereon at the rate of Seven & 1/2 per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is Twenty-five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the northern side of Henderson Road, being shown as Lot 78 on plat of Section F, Gower Estates, recorded in Plat Book JJJ at page 99, and having according to said plat the following metes and bounds:

Beginning at an iron pin on the northern side of Henderson Road at the point front corner of Lots 78 and 79 and running thence with line of Lot 79, N 21-42 W 278.1 feet to an iron pin; thence continuing N 61-38 W 80 feet to an iron pin on Pimlico Road; thence with the southern side of Pimlico Road, S 32-05 W 120 feet to an iron pin; thence with line of Lot 77, S 28-39 E 289.2 feet to an iron pin on Henderson Road; thence with said Road, N57-55 E 110 feet to an iron pin, the point of beginning.
