TO ALL WHOM THESE PRESENTS MAY CONCERN:

Donald C. Wilson (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Fourteen Thousand and no/100----- DOLLARS (\$14,000.00), with interest thereon at the rate of 6 and 3/4%-----per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is twenty (20) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Penwood Lane in Paris Mountain Township, shown as Lot 51 on plat of Imperial Hills recorded in Plat Book BBB at page 35 and according to said plat the following metes and bounds:

Beginning at an iron pin on the northeastern side of Penwood Lane at the joint front corner of Lots 50 and 51 and running thence with line of Lot 50 N. 38-15 E. 166.2 feet to an iron pin at the joint rear corner of Lots 50, 51 and 52; thence with line of Lot 52, S. 27-30 E. 182.5 feet to an iron pin on Penwood Lane; thence with Penwood Lane as follows: S. 62-30 W. 75.2 feet, thence with the curve of said Lane, the chord of which is N. 54-40 W. 42 feet to an iron pin; thence N. 51-50 W. 100 feet to the point of beginning.
