Frances P. Donnelly

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty Four Thousand Three Hundred and no/100 (\$24,300.00)----- DOLLARS

(\$ 24,300.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty (30) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying and being near the City of Greenville, and being known and designated as Lots Nos. 6, 7, 8, 9 and 10 on plat of Lakewood Subdivision, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book Y at Pages 136 and 137, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the northwest intersection of Deborah Lane and deForest Circle and running thence N. 67-51 W. 158.5 feet to an iron pin; thence N. 27-24 W. 258 feet to point in high water line of Saluda Lake; thence along the high water line of Saluda Lake, the traverse line being N. 53-46 E. 77 feet and N. 42-41 E. 140.8 feet to a point; thence along Elizabeth Drive, S. 21-00 E. 454.4 feet, more or less, to an iron pin on Deborah Lane; thence along Deborah Lane, S. 75-14 W. 83.7 feet, more or less, to the point of BEGINNING.
