WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Five thousand and no/100ths ----- DOLLARS

(\$ 5,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Berkley Avenue and being shown and designated as Lot No. 18 of the Ethel Y. Perry Estate on a plat prepared by W. J. Riddle, dated November 1947, recorded in the RMC Office of the Greenville County Courthouse in Plat Book R, at page 127 and being more particularly described, to-wit:

BEGINNING at an iron pin on the southern edge of a five-foot sidewalk running along Berkley Avenue, said iron pin being at the joint front corner of Lots 18 and 19 and running thence along the southern side of said sidewalk S 80-52 E 95 feet to an iron pin at the joint front corner of Lots 17 and 18; thence along the rear line of Lots 14, 15, 16 and 17 S 43-00 W 162 feet more or less to an iron pin at the joint rear corner of Lots 18 and 19; thence along the common line of said Lots N 8-53 E 135.9 feet to an iron pin the point of beginning.

The above-described property is the same conveyed to the Mortgagor by deed of Hxt M. Perry, Trustee of the County of Greenville, dated July 1, 1952 and recorded in the RMC Office of the Greenville County Courthouse in Deed Book 459, at page 279.
