if not sooner paid, shall be due and payable on the first day of September , 1977.

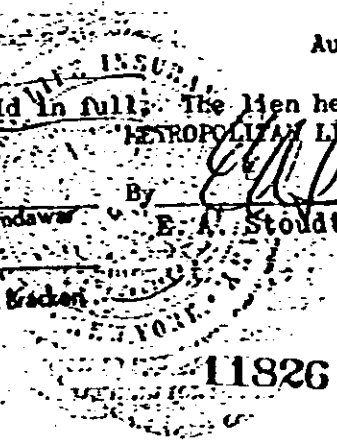
Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
