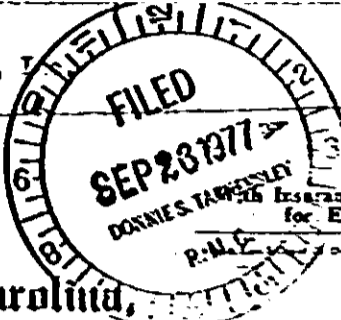

All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the Southern side of Bethuel Church Road about seven miles south of the City of Greenville, being shown as an unnumbered lot on plat of Subdivision of Air Base Highlands made by Dalton & Neeves, Engineers, August 1948 and recorded in the RMC Office for Greenville County in Flat Book 62 at Page 52, and having, according to a more recent survey by R. K. Campbell, Engineer, dated April 16, 1959, the following metes and bounds, to-wit:
