(hereinafter referred to as Mortgagor) SEND(S) GREETING

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty Three Thousand, Six Hundred and No/100----- DOLLARS (\$ 33,600.00), with interest thereon at the rate of seven & one-half per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is twenty-five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 2 of a subdivision known as Merrifield Park, Section II, according to a plat prepared by Piedmont Engineers & Architects, Surveyors, dated February 18, 1969, said plat being recorded in the R. M. C. Office for Greenville County in Plat Book WW at pages 50 and 51, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Connecticut Drive at the joint front corner of Lots 3 and 2 and running thence S. 57-33 E. 165 feet to an iron pin; thence running N. 32-27 E. 120 feet to an iron pin; thence running N. 57-33 W. 165 feet to an iron pin on the Eastern side of Connecticut Drive; thence with the Eastern side of Connecticut Drive S. 32-27 W. 120 feet to an iron pin, the point of beginning.
