TO ALL WHOM THESE PRESENTS MAY CONCERN: Robert L. Hinsdale and Margaret

Hinsdale (hereinafter referred to as Mortgagor) SEND(S) GREETING

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **Eleven thousand and no/100ths**-----DOLLARS

(\$ 11,000.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is **ten** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Brookwood Drive, being shown as Lots Nos. 5 and 6 of Block "G" of Stone Estates, said plat being recorded in Plat Book G at Page 292 in the RMC Office of the Greenville County Courthouse and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Brookwood Drive, at joint front corner of Lots 4 and 5 of Block G and running thence with the line of Lot 4 S 78-38 E 150.5 feet to an iron pin; thence N 9-30 E 50 feet to an iron pin at rear corner of Lot 7; thence with the line of Lot 7 N 78-38 W 149.6 feet to an iron pin on Brookwood Drive; thence with the eastern side of Brookwood Drive S 11-22 W 50 feet to the point of beginning.
