WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty-three Thousand Six Hundred ----- DOLLARS

(\$33,600.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 29 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Town of Mauldin, being shown as Lot No. 103 on a plat of Forrester Woods, Section II, dated March 17, 1973, prepared by Carolina Engineering and Surveying Co. and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4-X at page 64, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the eastern side of Overcreek Road at the joint front corner of Lots Nos. 106 and 103 and running thence with the line of Lot No. 106, S. 78-47 E. 150 feet to an iron pin; thence with the line of Lot No. 104, S. 11-13 W. 110 feet to an iron pin at the joint rear corner of Lots Nos. 102 and 103; thence with the line of Lot No. 102, N. 78-47 W. 150 feet to an iron pin on the eastern side of Overcreek Road; thence with the eastern side of Overcreek Road, N. 11-13 E. 110 feet to the point of beginning.
