(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eighty-five Hundred and No/100 DOLLARS (\$ 8500.00 ), with interest thereon from date at the rate of five & three-fourths per centum per annum, said principal and interest to be repaid as therein stated, and (5 3/4%)

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the north-eastern side of a county road which runs From Watkins Bridge Road in Paris Mountain Township, being shown as Lot No. 1 on plat of property of Mrs. Joe L. Watkins prepared by Terry T. Dill, May, 1956, recorded in P1 at Book FF, Page 425, according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the northeastern side of county road and running thence with the northeastern side of said road S. 20-20 E. 120 feet to an iron pin at the front corner of Lot 2; thence with the line of said lot N. 69-40 E. 175 feet to an iron pin rear corner of said lot; thence N. 20-20 W. 120 feet to an iron pin; thence S. 69-40 W. 175 feet to the beginning corner.
