All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville situate on the northern side of Beard Street and on the Southern side of Boling Circle in the County of Greenville, State of South Carolina, being shown as lot no. 1 on a plat of the property of Maggie B. Peterson dated January, 1973, prepared by Dalton & Neves, recorded in Plat Book 4T at Page 56 in the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:
