NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern side of Hollybrook Way, being shown as Lot No. 44 on a Plat of Holly Tree Plantation, Phase II, Section II, dated January 10, 1974, prepared by Piedmont Engineers and Architects, recorded in Plat Book 5D at Page 48 in the RMC Office for Greenville County and having according to said Plat the following metes and bounds to-wit:

BEGINNING at an iron pin on the southwestern side of Hollybrook Way of the joint front corner of Lots No. 43 and 44 and running thence with Lot 43 S. 2-17 W. 98.13 feet to an iron pin at the joint rear corner of Lots No. 42, 43 and 44; thence with Lot No. 42 S. 68-39 E. 138.9 feet to an iron pin at the joint rear corner of Lots No. 42 and 44; thence N. 16-00 W. 170 feet to an iron pin at the joint rear corner of Lots No. 44 and 45; thence with Lot 45 N. 82-50 E. 133.25 feet to an iron pin on Hollybrook Way; thence with said Way S. 39-30 E. 30 feet to an iron pin, thence still with said Way, S. 74-25 E. 30 feet to the point of BEGINNING.
