(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty One Thousand Six Hundred and No/100----- DOLLARS

(\$41,600.00----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the south side of Bridgewater Drive and the west side of Stoneybrook Drive, being shown as Lot 330, Sector VII of Botany Woods, recorded in the R.M.C. Office for Greenville, S. C. in Plat Book YY, Pages 76 and 77, and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Bridgewater Drive at the joint front corner of Lots 329 and 330 and running thence along the line of Lot 329 S. 17-21 E. 180 feet to an iron pin; thence N. 84-46 E. 139.5 feet to an iron pin on the west side of Stoneybrook Drive; thence along Stoneybrook Drive N. 12-10 W. 185 feet to an iron pin; thence with the curve of Stoneybrook Drive and Bridgewater Drive (the chord being N. 59-45 W. 33.6 feet) to an iron pin; thence along Bridgewater Drive S. 72-39 W. 129.3 feet to the beginning corner.
