WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-one Thousand Four Hundred and no/100 (\$21,400.00) DOLLARS, with interest thereon at the rate of Seven & 3/4 per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is Thirty years after the date hereof unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Lisa Drive near the City of Greenville, being shown as Lot 25 on plat of Wade Hampton Terrace made by Dalton & Neves, March 1955, recorded in Plat Book KK at page 15, and having the following metes and bounds:

Beginning at an iron pin on the western side of Lisa Drive at the joint front corner of Lots 24 and 25, and running thence along line of Lot 24, S 73-09 W 154.9 feet to an iron pin; thence N 15-16 W 100.05 feet to an iron pin; thence with line of Lot 26, N 73-09 E 152.4 feet to an iron pin on the western side of Lisa Drive; thence with Lisa Drive, S 16-51 E 100 feet to the beginning corner.

Derivation: Same property conveyed to mortgagors by Hayward M. Thompson, Jr., and Rosa T. Thompson, deed to be recorded herewith.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, mortgagors promise to pay to mortgagee the sum of 1/4% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan; and on his failure to pay it, mortgagee may advance it for mortgagors' account and
