NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 144 and the southerly and adjoining 1/2 of Lot 145 on plat of Cleveland Forest recorded in Plat Book M at page 137, and having the following metes and bounds:

Beginning at an iron pin on the northeastern side of Trails End at the joint front corner of Lots 143 and 144; thence N 64-35 E 166.9 feet to an iron pin at joint rear corner of Lot 143; thence with boundary line of unnamed road N 26-35 W 90 feet to an iron pin at rear corner of Lot 145; thence S 64-35 W 165 feet more or less to an iron pin, front center of Lot 145; thence S 25-25 E 90 feet along Trails End to an iron pin at the joint front corner of Lots 143 and 144, the point of beginning.
