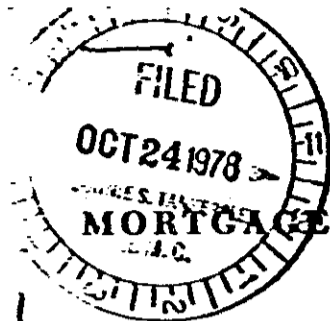

This is the same property conveyed by deed of Winslow Incorporated dated 12-21-70 recorded 4-7-77 in volume 1054 at page 300.

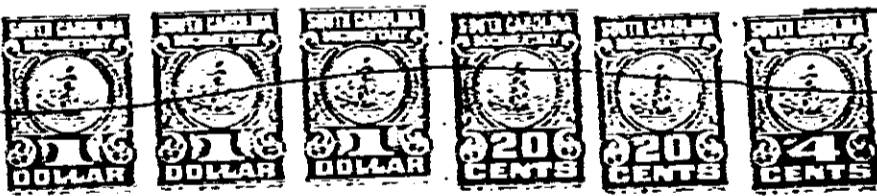
