# MORTGAGE

Dollars (\$ 11,600.00) with interest from date at the rate of five & one-fourth per centum (5 1/4%) per annum until paid, said principal and interest being payable on the first day of each month. All that certain piece, parcel or lot of land in the town of Travelers Rest, County of Greenville, State of South Carolina, at the southwest corner of the intersection of Tigerville Road and Dell Circle, and being known and designated as Lot No. 2 of the subdivision known as Brookgreen, a plat of which is recorded in the R. Beginning at an iron pin on the southern side of Tigerville Road at the joint corner of Lots Nos. 1 and 2 of said subdivision, and running thence with said Road, N. 89-59 E. 117.6 feet to an iron pin; thence around the curve of the intersection of said Road and Dell Circle, S. 44-23 E. 42.4 feet to an iron pin on said Circle; thence continuing with said Circle, S. 2-35 E. 116 feet to an iron pin at the corner of Lot No. 3; thence S. 71-48 W. 110 feet to an iron pin; thence N. 15-37 W. 184.7 feet to an iron pin, the point of beginning.
