(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty nine thousand six hundred fifty and 00/100 (\$29,650.00)-----DOLLARS

(\$29,650.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 29 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot No. 34, shown on a plat of the subdivision of Westminster Village, Section II, recorded in the RMC Office for Greenville County in plat book 5P at page 93, and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Woodstock Lane, joint front corner of Lots 33 and 34 and running thence with the joint line of said lots N. 04-49 E. 148.60 feet to an iron pin in line of property of J. C. Phillips; thence with the line of said property N. 71-37 W. 130 feet to an iron pin, joint corner of Lots 34 and 36; thence with joint line of Lots 34, 36 and 35 S. 00-47 E. 197.38 feet to an iron pin on the northern side of Woodstock Lane; thence with the northern side of said street N. 85-37 E. 108.49 feet to the point of beginning.
