WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Ward One of the City of Greenville, being shown as Lot No. 24 on plat of W. C. Cleveland property and Lot 23, Page 3, of Book 9 of the County Block Book, and having the following metes and bounds:

Beginning at a point on Neal Street at the joint corner of Lots 24 and 25, and running thence with Neal Street, N. 76 W. 62 feet to corner of Lot No. 23; thence with line of Lot 23, S. 14 W. 160 feet to an iron pin on an alley; thence with said alley, S. 76 E. 62 feet to corner of Lots 25 and 24; thence with line of Lot 25, N. 14 E. 160 feet to an iron pin, the point of beginning.
