TEASLEY EUGENE CLEVELAND and ELIZABETH N. CLEVELAND

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Eleven Thousand Seven Hundred and no/100

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the City and County of Greenville, being shown as a portion of lot 13 on plat entitled "Home Place of W.P. McBee, recorded in the R.M.C. Office in plat book "A", page 83, and having the following netes and bounds, to-wit:

Beginning at an iron pin on the northeastern side of Pinckney Street, at the corner of lot 15, and running thence with it N 39-30 E 174 feet to an iron pin; thence through the rear portion of lot 13, S 50-30 E 65 feet to an iron pin in the line of lot 11; thence with it S 39-30 W 174 feet to an iron pin on the northeastern side of Pinckney Street; thence with the northeastern side of Pinckney Street N 50-30 W 65 feet to the point of beginning.
