(hereinafter referred to as Mortgagor) SEND(S) GREETINGS

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of FORTY-FIVE THOUSAND SIX HUNDRED AND NO/100THS----- DOLLARS

(\$ 45,600.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being in the Town of Mauldin, being known and designated as Lot 11 of an Addition to Knollwood Heights as shown on plat thereof prepared by Piedmont Engineers and Architects, June 2, 1966, and recorded in the R.M.C. Office for Greenville County in Plat Book PPP at Page 6, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northwestern edge of Edgewood Drive, joint front corner of Lots 10 and 11 and running thence along the joint line of said lots, N 47-27 W, 165 feet to an iron pin; thence N 42-33 E, 120 feet to an iron pin, joint rear corner of Lots 11 and 12; thence along the joint line of said lots, S 47-27 E, 165 feet to an iron pin on the northwestern edge of Edgewood Drive; thence along the northwestern edge of Edgewood Drive, S 42-33 W, 120 feet to the beginning corner.
