WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **Forty-four Thousand Six Hundred and No/100----- DOLLARS**

(\$ 44,600.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is **29** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the North side of an un-named County Road running South from Jones Mill Road, and being shown as all of Lots N-17 and N-16 of Section N-3 on plat of Property of Whippoorwill Development Company, Inc. (Section 3-N), prepared by Enwright Associates, Engineers, August 21, 1969 (as revised October 13, 1971), which plat is recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 4-L, at Page 155, and having, according to said plat, the following metes and bounds, to-wit:
