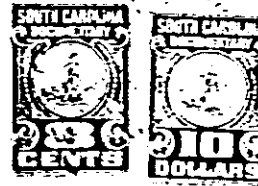

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greer, on the southern side of Rosco Drive and being known and designated as Lot No. 6 of BROOKHAVEN Subdivision as shown on a plat prepared by H. S. Brockman, December 12, 1957 and amended September 1, 1959 and according to said plat, having the following metes and bounds, to-wit:

Beginning at an iron pin on the southern side of Rosco Drive, corner of Lots Nos. 5 and 6 and thence running along line of said Lots, S.10-55 W. 170 feet to an iron pin on the rear corner of Lot No. 24; thence along the line of Lot No. 24, S.79-25 E. 100 feet to an iron pin to the corner of Lot No. 7; thence along line of Lot No. 7, N.10-55 E. 170 feet to the southern side of Rosco Drive; thence along said Drive, N.79-25 W. 100 feet to the beginning corner.
