WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of FIFTEEN THOUSAND AND NO/100 ----- DOLLARS

(\$ 15,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 15 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate, lying and being on the southeastern corner of the intersection of Oak Park Drive and Miller Road, in the Town of Mauldin, being known and designated as Lot No. 4 on a plat of Parkwood, Section 1, made by C. O. Riddle, dated July 27, 1969, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book 4-F, page 22, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Miller Road at the joint front corners of Lots Nos. 3 and 4, and running thence along the common line of said lots, S. 83-53 E., 150 feet to an iron pin; thence along the common line of Lots Nos. 4 and 5, N. 6-07 E., 100 feet to an iron pin on the southern side of Oak Park Drive; thence along the southern side of Oak Park Drive, N. 74-11 W., 75.7 feet to an iron pin; thence continuing along the southern side of Oak Park Drive, N. 83-53 W., 50.5 feet to an iron pin; thence with the curve of the intersection of Oak Park Drive and Miller Road, the chord of which is S. 51-07 W., 35.3 feet to an iron pin on the eastern side of Miller Road; thence with the eastern side of Miller Road, S. 6-07 W., 87.8 feet to an iron pin, the point of BEGINNING.
