All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, in Ward One, on Milton Street, and having the following notes and bounds, to-wit:

Beginning at a point on Milton Street, 266 feet from Park Avenue (formerly Carrier Street), and running thence S. 76 E. 186 feet to a 14-foot alley; thence with said alley N. 14 W. 38 feet to the northeast corner of said lot; thence N. 76 W. 186 feet to the west side on Milton Street; thence along Milton Street S. 14 W. 38 feet to the beginning corner, being Lot No. 28 on plat recorded in the R.
